Representative Cases:

FEDERAL

United States v. Albritton (CIETC Case)

Charges: Conspiracy to commit fraud or misapplication of Federal Funds and defraud the United States by impeding, impairing, obstructing and defeating the lawful government functions of the United States Department of Labor and the United States Department of Health and Human Services.

Result: NOT GUILTY VERDICT (Multiple defendant 2 + week trial)

United States v. Singh

Charges: False Statements in SBA Application / Mail Fraud

Result: Dismissal of Charges

United States v. Pruett

Charges: 9 Count Indictment, Including Conspiracy to Distribute Methamphetamine, Distribution of Methamphetamine, 2 counts Use of firearms in furtherance of a Drug Trafficking Crime (44 year mandatory minimum term)

Result: Not Guilty 2 Counts (one count of Use of Firearm), Guilty of Lesser included Drug Conspiracy, Sentenced to 148 months and on appeal Second Firearm charge dismissed. Sentence reduced to 108 months.

United States v. Jefferson

Charges: False Statement in Immigration Document

Result: Guilty Plea with Variance from US Sentencing Guidelines Credit for Time Served (total 1 day)

United States v. Buchholz

Charges: Conspiracy to Distribute Methamphetamine, Second Offense

Result: Guilty Plea with Variance from US Sentencing Guidelines Credit for Time Served (total 17 days)

United States vs. Wingrove

Charges: Conspiracy to Distribute, Conspiracy to Possess with the Intent to Distribute Methamphetamine and Marijuana within 1000 feet of a School.

Result: NOT GUILTY VERDICT ALL COUNTS.

United States vs. Hill

Charges: 26 Count Indictment, Tax Evasion and Illegal Distribution of Pharmaceutical Narcotics.

Result: Plea to Tax and Distribution Plea—5 YEAR sentence.

United States vs. Smitherman

Charges: Perjury.

Result: Not Guilty Verdict.

United States vs. Williams

Charges: Conspiracy to Distribute Cocaine.

Result: Not Guilty Verdict.

STATE

State v. Christensen

Charge: Sexual Abuse 2nd Degree aiding and abetting,

Result: Guilty Verdict

State v. Blanchard

Charge: Domestic Abuse Assault, Interference with emergency communications

Result: All Charges Dismissed immediately prior to trial

State v. McClintock

Charge: Possession With intent to Deliver (1.5 Lbs Marijuana)

Result: Plea to Misdemeanor Possession of Marijuana

State v. Feller

Charge: Domestic Abuse Assault

Result: NOT GUILTY VERDICT

State of Iowa vs. Bruner

Charge: Murder in the First Degree.

Result: Murder Dismissed; Plea to Conspiracy to Distribute Cocaine, No Mandatory Minimum Sentence.

State of Iowa vs. Thornton

Charges: Burglary 1st Degree, 2 Counts Domestic Abuse Assault, Interference, Violation No-Contact Order.

Result: All Substantive Counts Dismissed. Stipulation to No-Contact Order Violation.

State of Iowa vs. Huss

Charge: Murder in the First Degree (Class A).

Result: Not Guilty by Reason of Insanity.

State of Iowa vs. Jeffers

Charges: Conspiracy to Manufacture Methamphetamine, Manufacturing Meth., 4 counts possession of precursors.

Result: NOT GUILTY VERDICT ALL COUNTS.

State of Iowa vs. Negrete No.1

Charges: Assaults (hate crime),

Result: NOT GUILTY VERDICT 2 COUNTS, Directed Verdict 1 count , Guilty verdict of assault without intent (LESSER included).

State of Iowa vs. Negrete No. 2

Charges: Willful Injury, Assaults

Result: NOT GUILTY VERDICTS, Guilty verdict of assault without intent (LESSER included).

State of Iowa vs. Negrete No. 3

Charges: Felon in Possession of a firearm (3 separate cases).

Result: Dismissal

State of Iowa vs. Negrete No. 4

Charges: Arson (1 week trial).

Result: Conviction

State of Iowa vs. Dawson

Charges: Sexual Abuse 3rd Degree (3 counts).

Result: Simple Assault with Deferred Judgment.

State of Iowa vs. Dudley

Charges: Domestic Abuse Assault.

Result: Dismissal.

State of Iowa vs. Mack

Charges: Kidnapping 1st & Robbery 1st.

Result: Not Guilty Verdict.
